It is an offence for someone who is prohibited under Section 21 to have a firearm & ammunition in his/her possession at any time. Section 21 applies to anybody who has been sentenced to imprisonment or youth custody or detention in a young offender's institution for three months or more. The period for which they are prohibited depends on their length of service- if the sentence was longer than three years, the prohibition is for life. If the sentence was for three months or more but less than three years, the prohibition lasts for five years from the date of release. It is an offence for that person to transfer, let or hire, give or lend a firearm or ammunition to someone whom he/she knows or has reasonable grounds for believing to be prohibited by Section 21.
